SPECIAL PROGRAMS FOR DISABILITIES**

RECTOR OF INDONESIAN INSTITUTE OF THE ART PADANGPANJANG

- Considering :
- that limited access to universities in Indonesia for people with disabilities encourages the Padang Panjang Indonesian Serti Institute to become a pioneer of disability-friendly campuses in Indonesia;
 - that the Indonesian Institute of the Arts Padang Panjang has a mission to realize quality, characterful, sustainable education and the implementation of independent learning to improve quality graduates;
 - that the Indonesian Institute of the Arts Padang Panjang has a disability-friendly campus grand design which is realized with the Disability Service Unit
 - that based on the considerations as referred to in letters a, b, and c, it is necessary to establish a Rector's Regulation on the New Student Admission System Through the Selection of Special Programs for Persons with Disabilities

DECIDED:

Determine : **RECTOR REGULATION ON ADMISSION OF NEW STUDENTS THROUGH THE SELECTION OF SPECIAL PROGRAMS FOR DISABILITIES AT INDONESIAN INSTITUTE OF THE ART PADANGPANJANG**

Article 1

In this Decree, the following terms are defined:

1. The institution is the Indonesian Institute of the Arts Padangpanjang.
2. The Rector is the Chairman of the Indonesian Institute of the Arts Padangpanjang.
3. The Disability Service Unit, hereinafter abbreviated as ULD, is part of an institution or institution that functions as a provider of services and facilities for Persons with Disabilities.
4. Persons with Disabilities are any person who experiences physical, intellectual, mental, and/or sensory limitations for a long period of time who in interacting with the environment can experience obstacles and difficulties to participate fully and effectively with other citizens based on equal rights.
5. The Selection of Special Programs for Persons with Disabilities, hereinafter abbreviated as SPKPD, is a new student admission system specifically intended for people with8. Education Personnel are members of the community who devote themselves and are appointed to support the implementation of higher education at ISI Padangpanjang.

Article 2

The campus opens a special pathway for undergraduate and applied undergraduate programs for students with disabilities through SPKPD

1. SPKPD as directed in paragraph (1) will be investigated by ULD which will be integrated with the regular student admission system.
2. In carrying out SPKPD as referred to in paragraph (1), ULD carries out the selection of new students to participate in the national selection of new student admissions (SNPMB).
3. The registration of prospective students with disabilities who are accepted in this special program will be integrated with the admission committee New Student of the Indonesian Institute of Padangpanjang and supervised by ULD.

Article 3

1. SPKPD registration is done online, by filling out the form that has been provided.
2. For prospective students with disabilities who meet the :3 administrative requirements will be called to take part in the learning simulation of basic courses, psycho test, instrument test.
3. The summoning of prospective students with disabilities to take the test will be carried out by ULD and the ULD decision cannot be contested.

Article 4

The SPKPD age requirements are as follows:

1. SPKPD participants are Indonesian Citizens (WNI);
2. SPKPD participants with disabilities are the Visually Impaired and the Deaf, and the Blind Persons;
3. Applicants with disabilities have good academic potential;
 - a. For SPKPD participants who choose a study program at the Faculty of Fine Arts and Design do not have a disturbance in their sense of vision.
 - b. For SPKPD participants who choose the CLI study program of the Faculty of Performing Arts, they do not have any impairment in their sense of hearing.
4. SMA/SMK/SMALB/Madrasah Aliyah students who will graduate in the current year
5. SMA/SMK/SMALB/Madrasah Aliyah diploma or equivalent andat least have a Certificate of Exam Results. National (SKHUN) issued in the last 3 years of the year of the registration period.

The requirements for SPKPD registration are as follows:

1. Registration is done online by filling out the registration form through the website <https://isipadancipanianq.siakadcioud.com/sprnbfront> the-selection process by entering all the necessary data correctly.
2. Make payment of the registration fee through the virtual account (VA) code that you have received during registration.
3. Payments are made through partner banks of the Indonesian Institute of the Arts Padangpanjang.

Registration Schedule

1. SPKPD registration is carried out on a special schedule.
2. Information on the registration schedule and announcement of selection results will be announced through the official website of barn isi padang student admissions

Article 5

This Rector Regulation shall come into force on the date of stipulation.
